- 4. CURRENT RÉSUMÉ
- 5. PERSONAL STATEMENT (250 500 WORDS)
- 6. UNOFFICIAL TRANSCRIPTS (OFFICIAL TRANSCRIPTS WILL BE REQUIRED AFTER ADMISSION)
- 7. 3.0 UNDERGRADUATE GPA <u>OR</u> GRE SCORES <u>OR</u> (IF YOU HAVE 3+ YEARS OF FULL-TIME EXPERIENCE) A WORK PORTFOLIO
